Reference: Treasurer's Report for September 5, 2017

Revenue Sharing: Enclosed for the City Commission's reference and use you will find a historical graph and two tables presenting the State Revenue Sharing Disbursements that the City of Clare has received over the past 20 fiscal years.

As presented with the enclosed graph and table total constitutional revenue sharing has increased \$13,682 or 5.76% over the previous year. Unfortunately, for the past three consecutive fiscal years discretionary revenue sharing that is controlled by the state legislature and governor was unchanged.

Summer 2017 Property Collection: As of August 31, 2017 86.04% of the summer 2017 property tax roll has been paid as compared to 87.8% of the summer 2016 property tax roll as of the same time period in 2016.

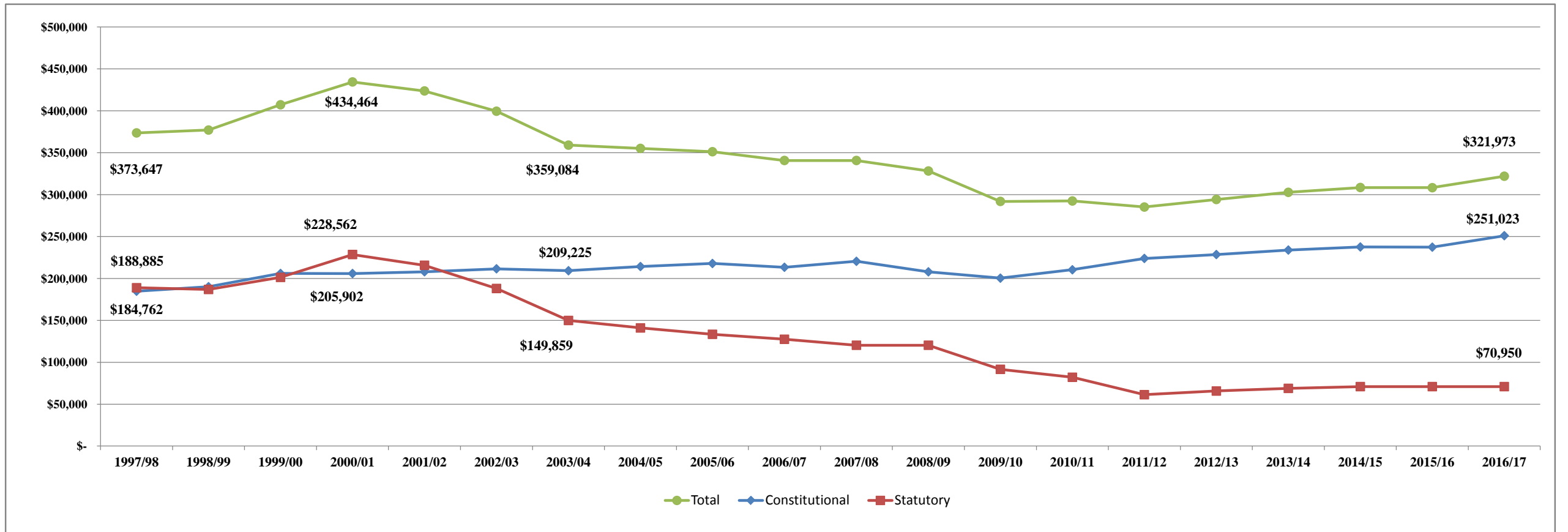
An eleven year history is attached for the Commission's reference.

Act 51 Road Funding Increased Distributions: In accordance with the road funding changes implemented by the Michigan Legislature in 2015 and effective January 1, 2017 the Act 51 Road Funding that is distributed by MDOT has increased. Included for the City Commission's reference you will find the monthly/annual history of the Act 51 funding received by the City of Clare for both major and local streets. Within these two spreadsheets the percentage increase/decrease from the same prior period is also included.
