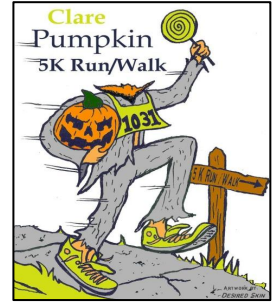


CLARE PUMPKIN RUN/WALK
